CORSE PARISH COUNCIL

Minutes of a bi-monthly meeting held on Tuesday 7th March 2023 held at Corse and Staunton Village Hall at 7.30pm.

Present: Cllr R Hall (Chair), Cllr M Jones, Cllr P Burford, Cllr T Jones, Cllr D Preston, Cllr B Buck.

The meeting was chaired by Cllr R Hall and the minutes were taken by the Clerk.

Dave Williams attended as the Staunton Parish Council representative.

1. Apologies for absence

Apologies were received and accepted from Cllr A Collings.

2. Declarations of Interest

Declarations of interest were received from Cllr T Jones and Cllr B Buck regarding the Donation discussions for the Cricket Club and the Village Hall respectively and from Cllr D Preston re discussions on the Fourviews Planning application.

3. Minutes of previous meeting(s)

It was proposed by Cllr D Preston that the minutes of the Ordinary Meeting held on the 3rd January 2023 be accepted as a true record, this was seconded by Cllr T Jones, the minutes were agreed by all Cllrs present.

4. Public consultation

David Williams advised that a litter pick had taken place from Barn Lane to the Bakery Junction and a total of 12 black sacks were filled. The Parish Council wished to minute thanks to those involved.

5. Reports

- 5.1 District Councillor Brian Lewis sent his apologies.
- 5.2 District Councillor Philip Burford gave a brief overview of the past 4 years and spoke to Cllrs about the Cinderford Northern Quarter report.
- 5.3 County Councillor Philip Robinson spoke to Cllrs about the build back better scheme and advised that applying was still worthwhile.

Cllr Robinson advised that the repairs/resurfacing needed from the Waters Meet through to the Worcester Road junction is on the list to be done and will seek a date for this work and will advise the Clerk. Cllr Robinson has also taken away concerns expressed regarding the patching works on the A417 that have taken place as these have already broken up/come out and the surface is terrible again.

6.2 Financial statement and cash re-conciliation

It was proposed by Cllr B Buck to agree the financial statements and cash re-conciliation as of January this was seconded by Cllr M Jones and agreed by all Cllrs, and it was resolved to accept the statements.

6.3 Quarterly Financial Check

Cllr M Jones has carried out a Financial Check and confirmed that all was in order.

6.4 Internal Auditor 2022-23

The appointment of the Internal Auditor was discussed and it was proposed by Cllr B Buck that the audit should be carried out by GAPTC at a cost of £180.00, this was seconded by Cllr M Jones and agreed by all Cllrs present. The Parish Council assured itself that the Internal Auditor is competent and independent.

6.5 Insurance Renewal

The insurance renewal was discussed and it was proposed by Cllr D Preston to renew with Zurich for the 2nd year of the LTA, this was seconded by Cllr T Jones and agreed by all present, the cheque was raised.

6.6 Flag

The Clerk circulated various flag designs for the Kings Coronation after considering the options Cllrs nominated their preferred flag and one design was unanimously chose, it was agreed by all Cllrs present to purchase the flag for flying during the coronation, it was also agreed that this would then be donated to the Village Flag Collection.

6.7 Benches

Cllr M Jones advised that the benches would need to be treated every three years and it was agreed to add this to a three year programme, Cllr M Jones is to purchase the appropriate treatment on behalf of the Parish Council and it was agreed that Cllr Jones will then carry out the treatment.

6.8 Bus Shelter Area and Annual Maintenance Programme

The quotation of £300 received from Greenfinch was discussed further following the January meeting and it was resolved by all Cllrs present to accept the quotation and proceed with the works to include the clearing back of the hedge on the bus shelter side.

6.9 Phone Box

The insurance reimbursement has been received and the door has been paid for and ordered, as soon as the door is ready to be delivered the Clerk will be advised of a delivery date.

6.10 The Pound

The Clerk advised that both parties have signed the agreement as provided by RG & RB Williams. The rental is being received at the beginning of each month.

6.11 Donations

The annual donations were discussed, q request for funding and a copy of the accounts was received from all groups with the exception of the Cricket Club who did not wish to apply. Following discussion it was proposed by Cllr M Jones that the following donations be made:
