P0774/23/TCA	Windrush House, 7 Grange Close	Row of 3 x Copper Beech on the rear boundary - Remove significant deadwood from tree nearest the house. Fell remaining 2 Copper Beech trees to near ground level, due to having lost more than 50% of their crowns to dieback due to soil compaction as a result of construction work when the houses were built. Oak tree beside the house - reduce in size to leave approximately 11.0m tall (2.0m off the height) and with a radial crown spread of approximately 5.5m (1.5m off the spread). Eucalyptus in the corner by the pond - this tree has girdling roots and is dying back in the crown now 40% dead. Fell to near ground level and treat stump to discourage re-growth
P0284/23/FUL	Windrush Barn, Church Lane	Erection of a three bay green oak timber garage adjacent to an existing garage
P0635/23/PQ3PA	Oakbank, Newent Road, Staunton	Prior approval for the change of use from agricultural building to dwelling house (C3) and for building operations reasonably necessary for the conversion
