8.1 Flooding

8.2 Highways report

The Highways report was discussed and it was agreed that the Clerk would chase up the cutting back of the verge and hedge at the junction of Oridge Street and the A417.

The Clerk is to also chase the cleaning of the drains through the Village as these have still not been cleared.

P1159/23/TCA	Prince of Wales, Gloucester Road	T1 Walnut: Dismantle the tree and grind out the stump, remove all arisings from site, and replant with an English oak (Quercus robur) nearby in an appropriate location. Reason: The tree is almost completely dead, and there is evidence of decay on two main structural limbs, meaning that structural failure (in proximity to a Listed building) is reasonably foreseeable. T2 Robinia (adjacent to Walnut and growing up and through large Hazel): Fell to ground level and poison stump to prevent regeneration. Reason: Upper part of the tree is dead. No amenity value.	Corse Parish Council considered the planning application for Prince of Wales and support this application to protect the future of the building.
